Supervisor Kainz gave a summary of the Insurance costs for 2020. The current provider, Blue Cross Blue Shield continued to be the best choice. There will be an increase of 7.63% from the previous year. There was discussion regarding the previously implemented policy that all new hires now pay 10% of the premium costs.

Trustee Talbot made a motion which was seconded by Trustee Parisi to approve the Health Insurance Plan for 2020. The motion was approved by a unanimous voice vote.
