VII. Items for Consideration and Adoption

A. Annual Audit for Fiscal Year ending 2/28/2022

Macabe Thorpe of Lauterbach & Amen presented the audit findings for fiscal year 2021-2022. The Township has received an unmodified opinion again this year. This is the highest rating awarded in the government sector. Trustee Talbot made a motion that was seconded by Trustee Kusmerz to approve the Annual Audit for fiscal year ending 2/28/22.

Roll Call: Born-absent; Kusmerz-yes; Andreae-yes; Talbot-yes; Karam-yes. Motion Carried.

B. Landscape Design

Knapik reported that the design contact has been hard to get a hold of. She will try and have an update next month.

C. Cemetery Fencing

Knapik reported that she received quotes from Peerless Fencing for the cemetery project. She presented the various options to the Cemetery Board, and they chose to move forward with the most conservative option.

D. Sirens

Karam reported that we are approved for a \$30K grant for a new siren. Unfortunately, the cost of a siren has increased to \$39K in the last year. The township needs to assess what this price difference means to our budget. We will revisit this issue at our August meeting.

A. Assessor's Report

Knapik reported that blue notices have been mailed and should be hitting mailboxes in the next day or two. She is anticipating a small number of appeals. The county came back with a final factor of 1.73%

B. Clerk's Report

Shannon reminded the elected board members to please finish and submit FOIA and OMA trainings.

C. Highway Commissioner's Report

Podgorski reported the July 4th windstorm created a large amount of damage to the area between Kelsey Road and Route 22. It has taken almost a full 2 weeks to get all the brush cleaned up. Hart Road was supposed to be completed by now. The union is on strike and as a result all paving projects are pushed out. Podgorski says he has been in contact with the county to try and find a way to move this project along and get it completed.

D. Supervisor's Report

Karam reported that the July 2nd race was a success. There were 120 runners that participated, and between \$8-9,000 was raised for Folds of Honor. Karam also addressed the sirens. Funding 9 new sirens is a challenge, so Karam is looking into the possibility of selling some land the township owns to cover the cost of the replacement project. Fall Fest is September 24th. The township is looking for sponsors to cover food trucks, music, and other entertainment.
