Karam reported the township looked at several options for next year's insurance plan. The current plan is the best option by only showing a .55% increase in cost. He recommended approving the existing plan for 2024.

Trustee Andreae made a motion that was seconded by Trustee Talbot to approve the Insurance plan for 2024.

C. Roof Bid Discussion

Karam discussed the roof during the Supervisor's report.

A. Resolution 23-R-01

A Resolution Adopting the General Town and Road District Levy Estimate for 2023

Karam gave an overview of both the General Town and Road District Levy options. The CPI for this year is 6.45%. Karam explained that we would like to keep the levy amount equal to last year's figure so as to not implement any increase on township residents. Podgorski reported that material and labor costs have continued to rise. To continue to effectively service township residents he needs to ask for a modest increase.

Trustee Talbot made a motion which was seconded by Trustee Born to approve the Levy Estimate in the amount of \$1,128.000 for the General Town and \$2,288,000 for the Road District.

Podgorski reported that have completed all paving projects for the year. The week of Thanksgiving the Road Crew will be doing test runs of the routes for snow removal. Firewood Fridays are back every other Friday through March.

D. Supervisor's Report

Karam reported that because of the quadrennial, he has received several calls from upset Cook County residents regarding their tax bills. Cook County experienced a large reduction of commercial value resulting in a larger amount of tax burden to be transferred to residential homeowners. Karam is looking to put together a "Taxpayer Bill of Rights". The purpose of this would be to have a uniform protocol on hand to answer tax related concerns and questions from township residents when they arise. On Sunday, November 5, the BACF youth advisory counsel brought a large food drive donation to the pantry. These are much needed as we are now providing food to over 50 families. LBS started a food drive that will run through December 16th. Karam reported that we will be formally going out to bid to replace the building's roof. Initial costs seem to be in the \$40K range, which requires us to go through a formal process. He still foresees this project being completed before winter.
