RESOLUTION NO. 23-R-01

A RESOLUTION ESTABLISHING REGULAR MEETING DATES AND HOLIDAYS FOR CUBA TOWNSHIP FOR 2024

WHEREAS, Section 2.02(a) of the Open Meeting Act, 5 ILCS 120/2.02(a) requires that every public entity shall give public notice of the schedule of regular meetings at the beginning of each calendar or fiscal year; and

WHEREAS, Section 2.02(a) of the Open Meetings Act also requires the Township to set the regular dates, times and places of such meetings; and

WHEREAS, the Township Board would also like to establish the holidays for 2024; and

WHEREAS, the Township Board, by this Resolution, hereby sets the schedule of regular meetings and holidays for 2024.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWNSHIP BOARD OF CUBA TOWNSHIP, LAKE COUNTY, ILLINOIS, as follows:

SECTION 1: The Township Board of the Cuba Township shall hold regular Township Board meetings at 6:00 p.m. on the 2nd Thursday of each month, unless noted below, pursuant to the following schedule:

January 9	July 11
February 8	
February 29	August 8
March 14	September 12
April 9	October 10
May 9	November 14
June 13	December 12

SECTION 2: All regular meetings of the Township Board will be conducted at the Cuba Township offices, 28000 West Cuba Road, Barrington, IL 60010

SECTION 3: Nothing in this Resolution shall be construed to prevent the Township Board from cancelling a regular meeting or changing the date, time, or location of any regular meeting, provided that notice of the changed date, time or location will be given in accordance with all applicable provisions of the Open Meetings Act.

SECTION 4: The following dates shall be declared holidays in Cuba Township for 2024. On these dates, the Township offices will be closed:

- January 1 - New Year's Day
- January 15 - Martin Luther King Jr. Day
- February 19- President's Day
- May 27 - Memorial Day
- June 19- Juneteenth
- July 4 – Independence Day
- September 2- Labor Day
- October 14 - Columbus Day
- November 11 – Veterans Day
- November 28 – Thanksgiving Day
- November 29 – Day after Thanksgiving
- December 24- Christmas Eve
- December 25 – Christmas Day

SECTION 5: If any section, paragraph, clause, or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Resolution.

SECTION 6: All Resolutions in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 7: This Resolution shall be in full force and effect from after its passage, approval and publication as provided by law.
