#### I. Call to order:

## IV. Discussion and potential action on approval of minutes:

## A. November 12th, 2020 – Regular Board Meeting

## A. Payment of bills

Trustee Talbot made a motion which was seconded by Supervisor Kainz to approve the bills of 11/6/20 - 12/2/20 in the amount of \$290,082.13 check nos. 49919 – 50021.

## B. Discussion regarding cemetery maintenance and fund availability

Knapik gave a summary of the current White Memorial funds availability and a list of maintenance items needing action this winter and early Spring. Of those items, tree removal is priority and will use up the cash on hand in the operating account. The remaining funds have been set aside as a "Perpetual Care Fund" and only interest was originally permitted to be removed. Knapik consulted with attorney Krafthefer who advised it would be reasonable to withdraw a portion of those funds for cemetery maintenance needs. Knapik asked the board to consider transferring unused budget funds in February to the cemetery for future repairs of the driveway, fence and camera system. The 20/21 Fiscal Year Budget allocated 100K for such purposes if they arose. This item will be voted on in a future meeting.

## C. Employee Insurance Plan 2021

Trustee Born reported that the insurance plan for 2021 will increase nearly 10%. It was agreed that due to the pandemic, a change to employee costs would not take place at this time. There was additional discussion of changing the employee responsibility portion within this calendar year or for the 2022 plan with additional discussion to take place in future meetings.

Trustee Born made a motion which was seconded by Trustee Talbot to approve the Employee Insurance Plan for 2021.

## C. Ordinance 20-O-05 – An Ordinance adopting the Road District Levy for 2021

Trustee Born made a motion which was seconded by Trustee Talbot to adopt the Road District Levy in the amount of \$2,055,251.14 which represents an increase of only new property capture.
