## RESOLUTION NO. 25-R-05

A RESOLUTION ESTABLISHING REGULAR MEETING DATES AND  
HOLIDAYS FOR CUBA TOWNSHIP FOR 2026

WHEREAS, Section 2.02(a) of the Open Meeting Act, 5 ILCS 120/2.02(a) requires that every public entity shall give public notice of the schedule of regular meetings at the beginning of each calendar or fiscal year; and

WHEREAS, Section 2.02(a) of the Open Meetings Act also requires the Township to set the regular dates, times and places of such meetings; and

WHEREAS, the Township Board would also like to establish the holidays for 2026; and

WHEREAS, the Township Board, by this Resolution, hereby sets the schedule of regular meetings and holidays for 2026.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWNSHIP BOARD OF CUBA TOWNSHIP, LAKE COUNTY, ILLINOIS, as follows:

**SECTION 1:** The Township Board of the Cuba Township shall hold regular Township Board meetings at 6:00 p.m. on the 2nd Thursday of each month, unless noted below, pursuant to the following schedule:

January 13	July 9
February 12	
February 27	August 13
March 19	September 10
<b>April 14</b>	October 8
May 14	November 12
June 11	December 10

**SECTION 2:** All regular meetings of the Township Board will be conducted at the Cuba Township offices, 28000 West Cuba Road, Barrington, IL 60010

**SECTION 3:** Nothing in this Resolution shall be construed to prevent the Township Board from cancelling a regular meeting or changing the date, time, or location of any regular meeting, provided that notice of the changed date, time or location will be given in accordance with all applicable provisions of the Open Meetings Act.

**SECTION 4:** The following dates shall be declared holidays in Cuba Township for 2026. On these dates, the Township offices will be closed:

January 1 - New Year's Day

January 19 - Martin Luther King Jr. Day

February 16- President's Day

May 25 - Memorial Day

June 19- Juneteenth

July 3 – Independence Day

September 7- Labor Day

October 12 - Columbus Day

November 11 – Veterans Day

November 26 – Thanksgiving Day

November 27 – Day after Thanksgiving

December 24- Christmas Eve

December 25 – Christmas Day


